## **Incident Report**

### **Cuba, September 2020**

---

**October 15, 2020**

The Complaints Center of the Pan-American Democracy Foundation (FDP) found a pattern of harassment and persecution against independent activists, political opponents, communicators, artists and others.

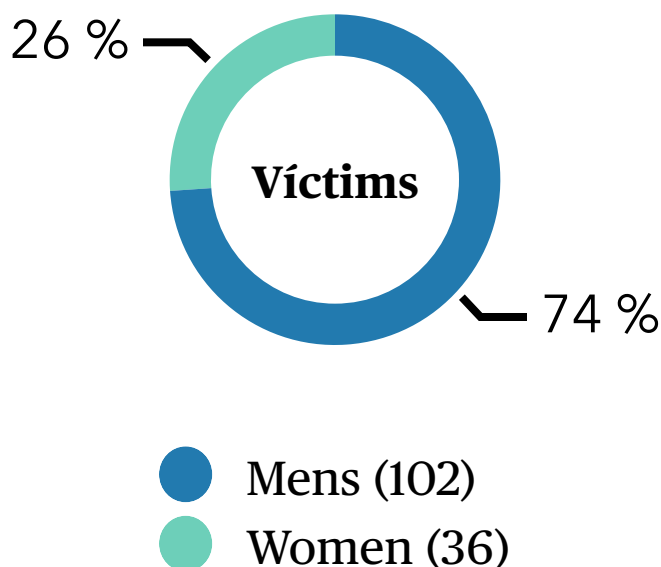
In the month of September 2020, it was verified that at least **94 incidents** were committed in Cuba throughout the country, with a total of **138 victims**. Of the total reported, **73 cases correspond to arbitrary detentions** in an effort to neutralize the work of dissident actors by the State Security forces, detentions that did not comply with due process procedures, with a total of **117 Cuban citizens detained arbitrarily** in the month.

**7 police citations** were received throughout the month by different UNPACU activists, promoters of Cuba Decide and independent citizens throughout the country, an opportunity in which the security agencies threatened victims and even attacked them, as evidenced by several testimonies received, in instances intended to reduce the space of action of the citizens.

Another common sanctioning practice, on the part of the authorities, is the financial impositions that are required of citizens. During the month **at least 18 fines were registered**; the penalties ranged from 30 to 3,000 pesos in national currency, which on average this month is around 809 pesos for those affected.

The events that occurred in the month warn of a worrying pattern of harassment to intimidate and criminalize the work of leaders and organizations of the opposition and independent civil society in Cuba, which are mentioned below:

- Arbitrary arrests.
- Surveillance, intimidation and harassment.
- Attacks on liberty and personal integrity.
- Attacks that threaten life and personal safety.
- Threats due to public complaints.
- Criminalization by official bodies.
- Arbitrary arrests, attacks and intimidation against journalists and communicators.
- Social control over the victim.
- Attacks against activists and promoters of human rights.



## Testimony

## Cases received

### **1. Victim: Noel Díaz Matos - Incident date: September 1, 2020 - Mayabeque**

The activist of the Opposition Movement for a New Republic, was accused of illegally leaving the country. Arrested on September 1 at 4:00 in the afternoon. According to their daughter, at the bottom of the land where the house is located a group of people were building a raft. Díaz Matos was detained at the Técnico de San José, the provincial capital of Mayabeque. State Security remains in charge of the case.

The activist has a visual disability (almost total) that would not allow them to participate in the construction of a raft to launch into the sea, as the authorities accuse them of doing.

### **2. Victim: Cosme Damián Domínguez Peñalber - Incident date: September 1, 2020 - Havana**

Cited to the police unit, threatened by State Security agents with prison for non-payment of fines.

### **3. Victim: Manuel Mustelier Tamayo - Incident date: September 1, 2020 - Santiago de Cuba**

Arrested while on a bus from his home to a cell located in Alto Songo. Released on September 8 in the afternoon to prevent his participation in the Sunflower Revolution.

### **4. Victim: Yanier Jouvert Cisneros - Incident date: September 3, 2020 - Guantánamo**

Taken as political prisoner serving a sentence in the Guantánamo provincial prison. He is in poor health. He was dragged down three floors by jailers from the Guantanamo provincial prison.



**5. Victim: Bartolo Cantillo Romero - Incident date: September 3, 2020 - Guantánamo**

Verbally subpoenaed to assist the Operations Unit of his province.

**6. Victim: Anamelys Ramos - Incident date: September 3, 2020 - Havana**

The teacher, activist and art curator, was expelled from the department where she resided in retaliation for being a Human Rights activist. Ramos has received numerous reprisals in recent times, for her to abandon her activism and support for other independent artists. She was also expelled from the Higher Institute of Art, where she taught for 12 years.

**7. Victim: Diosbel Veliz Marin - Incident date: September 4, 2020 - Havana**

The delegate of the Opposition Movement for a New Republic was arrested at 1 pm, and he was fined 2,000 pesos. He was later released.

**8. Victim: Anibal Riveaux Figueredo - Incident date: September 4, 2020 - Santiago de Cuba**

State Security agents aggressively surrounded his home for distributing sunflowers to the community. He was detained and tortured, taken to police unit #2, beaten for peacefully demonstrating, driven in a car on the outskirts of the city and threatened with death. His shoes were thrown into the sea.

**9. Victim: Roberto Serrano Delis - Incident date: September 4, 2020 - Santiago de Cuba**

Arrested when leaving the UNPACU headquarters, taken to police unit #2 where 20 CUC and 95 CUP were taken from him and he was threatened with invalidation of Doctor of Medicine title. Fined for trespassing the police fence that surrounds the headquarters of UNPACU, fined to pay 150 CUP.

**10. Victim: Ulises Toirac - Incident date: September 4, 2020 - Havana**

The comedian was arrested at a store in Miramar, and transferred to a police unit, on the morning of September 4 after a confrontation with an official of the Ministry of the Interior of Cuba (Minint).

**11. Victim: Raux Denis Rodríguez Rodríguez - Incident date: September 5, 2020 - Villa Clara**

In Santa Clara the activist of Juventud Despierta and the Civic Resistance Front Orlando Zapata Tamayo, Raux Denis Rodríguez were detained by police. In the video of the arrest, it can be seen how three officers also introduce into the 260V patrol a person who was accompanying Raux Denis without giving reasons for his arrest.

**12. Victim: Erick Guzmán Rodríguez - Incident date: September 5, 2020 - Las Tunas**

UNPACU activist, promoter of Cuba Decide, arbitrarily detained in his home.

**13. Victim: Rolando Mora - Incident date: September 5, 2020 - Las Tunas**

UNPACU activist, promoter of Cuba Decide, arbitrarily detained in his home.

**14. Victim: Cristian Perez Carmenate - Incident date: September 5, 2020 - Las Tunas**

Attacked at his home, by the political police agent Yosvani Ávila.

**15. Victim: Onel Napoles Fernández - Incident date: September 5, 2020 - Santiago de Cuba**

Arbitrarily detained, he was released at 9 a.m.

**16. Victim: Eulises Reyes Ramos - Incident date: September 5, 2020 - Santiago de Cuba**

Detained, threatened and released at 9 a.m.

**17. Victim: Bartolo Cantillo Romero - Incident date: September 5, 2020 - Guantánamo**

Fined by Decree-Law 370 to pay 3,000 CUP, according to article 370 paragraph 68 of the communications, it prohibits the dissemination or publication of information against the regime or the reality of Cuba.

**18. Victim: Rolando Mesa Benítez - Incident date: September 5, 2020 - Guantánamo**

Arbitrarily detained.

**19. Victim: Henry Couto Guzmán - Incident date: September 6, 2020 - Guantánamo**

Threatened for his political activism; Detained by agent Víctor and driven down the highway where he was pushed and his bicycle was broken.

**20. Victim: Jesús Sánchez Romero - Incident date: September 6, 2020 - Santiago de Cuba**

Arrested in his home, taken to police unit #2 and threatened with being taken to prison. Sánchez Romero was accused of putting up some posters that appear in the city calling for the Sunflower Revolution.

**21. Victim: Manuel Mustelier - Incident date: September 6, 2020 - Santiago de Cuba**

Arrested when he was traveling on a bus from his home Alto Songo, released on September 8 in the afternoon to prevent his participation in the Sunflower Revolution.

**22. Victim: Pedro Martínez Cardoso - Incident date: September 6, 2020 - Ciego de Ávila**

The UNPACU activist, promoter of Cuba Decide, was detained in his home, taken to the police unit, held incommunicado, began a hunger strike, and is accused of disobedience and resistance. Deported by State Security to his native Guantanamo province, for his political activism.

**23. Victim: Abel Peña Carvajal - Incident date: September 7, 2020 - Santiago de Cuba**

UNPACU headquarters in the town of El Cristo is under police blockade, to prevent the entry and exit of members of the organization, as a way to repress the peaceful protest, the Sunflower Revolution.

**24. Victim: Yordanis Labrada Tellez - Incident date: September 7, 2020 - Santiago de Cuba**

His home was under police blockade when he left to pick up his children from school; he was detained by State Security agents, threatened with going to prison for the false crime of “pre-criminal social danger.” He was detained for 24 hours, to prevent him from demonstrating peacefully in the Sunflower Revolution.

**25. Victims: Roilán Álvarez Rensoleer, Moraima Díaz Pérez, Isael Aliaga Pérez, Manuel Pérez Suárez, Oris Ramírez Leyva, Roberto Quiñones - Incident date: September 7, 2020 - Santiago de Cuba**

UNPACU activists, promoters of Cuba Decide, arrested for approximately 24 hours, taken to the Mella police unit, and threatened with going to prison for promoting the Sunflower Revolution on social media.

**26. Victim: Adrián Ochoa Portales - Incident date: September 7, 2020 - Santiago de Cuba**

Arrested for approximately 24 hours, taken to the Mella police unit, and threatened with going to prison for promoting the Sunflower Revolution.

**27. Victim: Omar Salas Hechavarria - Incident date: September 7, 2020 - Santiago de Cuba**

UNPACU activist, promoter of Cuba Decide, summoned for September 8, in the El Cristo police unit, threatened if he did not attend the summons.

**28. Victim: Ángel Suárez Cartaya - Incident date: September 7, 2020 - Santiago de Cuba**

Arbitrarily detained while he was traveling on a bus to Dos Caminos in San Luis, to prevent his peaceful participation in the Sunflower Revolution.

**29. Victim: Edgar Perez Perez - Incident date: September 7, 2020 - Santiago de Cuba**

Subpoenaed by the Las Tunas police unit, just hours after the call for the Sunflower Revolution demonstration.

**30. Victim: Henry Couto Guzmán - Incident date: September 7, 2020 - Guantánamo**

Detained on the public highway while leaving the headquarters of his province, his clothes were torn and his bicycle was thrown. He was threatened for his peaceful activism and with being taken to prison.

**31. Victim: Manuel Santana Vega - Incident date: September 7, 2020 - Havana**

Arbitrarily detained; His home in Santiago de las Vegas was raided. Police broke down his door and beat him; he was later taken to the Guanabo police unit. He is currently in quarantine in the 5th police unit in Playa, accused of the false crime of contempt.

**32. Victim: Ebert Hidalgo Cruz - Incident date: September 7, 2020 - Santiago de Cuba**

A State Security agent went to look for him at his home and detained him. He was transferred in a police patrol to the outskirts of the city, handcuffed, beaten by two policemen and threatened with death. It was also threatened that State Security was going to destroy his family and that his son, Evert Luis, would be taken to prison if he continues with his political activism. They left marks on his wrists and arms from the beatings.

**33. Victim: Yasmani Cárdenas Cabrera - Incident date: September 7, 2020 - Havana**

Arbitrarily detained on the day before the Sunflower Revolution.

**34. Victim: Rolando Rodríguez Lobaina - Incident date: September 8, 2020 - Guantánamo**

Harassed and monitored by the political police due to his opposition activities.

**35. Victim: Eduardo Cardet - Incident date: September 8, 2020 - Holguín**

The home of the former political prisoner woke up with his home surrounded by the police, on the 32nd anniversary of the founding of the Christian Liberation Movement (MCL).

**36. Victim: Yolanda Santana Ayala - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**37. Victim: Marieta Martínez Aguilera - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**38. Victim: Gladis Capote Roque - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**39. Victim: Micaela Roll Gibert - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**40. Victim: Cosme Damian Domínguez - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**41. Victim: Ángel Flores Martínez - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**42. Victim: Alexander Roll Gibert - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**44. Victim: Alexis Perez Lescaille - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**45. Victim: Sandalio Mejías Zulueta - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**46. Victim: Salvio Cobas Guilarte - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**47. Victim: Luis Manuel Otero - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**48. Victim: Roilan Álvarez - Incident date: September 8, 2020 - Santiago de Cuba**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.



**50. Victim: Isael Aliaga - Incident date: September 8, 2020 - Santiago de Cuba**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**51. Victim: Manuel Pérez - Incident date: September 8, 2020 - Santiago de Cuba**

Detained by the political police to prevent him from attending the peaceful demonstration of the Sunflower Revolution.

**52. Victim: Oris Ramírez - Incident date: September 8, 2020 - Santiago de Cuba**

Detained by the political police to prevent her from attending the peaceful demonstration of the Sunflower Revolution.

**53. Victim: Iván Hernández - Incident date: September 8, 2020 - Matanzas**

Detained by the political police to prevent him from attending the peaceful Sunflowers demonstration.

**54. Victim: Daniel Alfaro - Incident date: September 8, 2020 - Havana**

Detained by the political police to prevent him from attending the peaceful Girasoles demonstration.

**55. Victim: Iam Gámez Gell - Incident date: September 8, 2020 - Santiago de Cuba**

Arbitrarily detained in a bank in the center of the city, taken to police unit #2 where he remained for several hours, to prevent his participation in the peaceful protest, the Sunflower Revolution.

**56. Victim: Liusban Jhon Utra - Incident date: September 8, 2020 - Santiago de Cuba**

UNPACU activist, promoter of Cuba Decide, political express, detained around the organization's main headquarters in Santiago de Cuba, to prevent peacefully demonstrate in the Sunflower Revolution.

**57. Victim: Marina Paz Labaceno - Incident date: September 8, 2020 - Santiago de Cuba**

Arrested in front of the UNPACU headquarters, taken in a police patrol to unit # 2, beaten, admitted to the Gustavo Machín Psychiatric hospital, for speak out against the regime. Released that same day, hours later.

**58. Victim: Darien Columbie Grave De Peralta - Incident date: September 8, 2020 - Santiago de Cuba**

UNPACU activist, unjustly detained to prevent his participation in the Sunflower Revolution.

**59. Victims: Miraida Martin Calderin, Ernesto Riveri Gascón, Leonardo Riveri Gascon, Yumila Yesica Miranda, Ángel Hinojosa Castellano, Franklin Álvarez Fernández, Samuel Leblan Pavon - Incident date: September 8, 2020 - Santiago de Cuba**

Detained to prevent them from demonstrating peacefully in the Sunflower Revolution.

**60. Victims: José Daniel Ferrer García, José Daniel Ferrer Cantillo, Nelva Ismarays Ortega Tamayo - Incident date: September 8, 2020 - Santiago de Cuba**

Violently detained to prevent them from demonstrating peacefully in the Sunflower Revolution. Released after several hours of detention.

**61. Victims: Ebert Hidalgo Cruz, Evert Luis Hidalgo Ladrón De Guevara, Karel Reyes Revilla, Damir Rodríguez Cisneros - Incident date: September 8, 2020 - Santiago de Cuba**

Unjustly detained when leaving their home to prevent them from demonstrating peacefully in the Sunflower Revolution.

**62. Victims: Omar Salas, José Antonio Bell, Justino Bell, Geovanis Benitez, Yunior Matamoros - Incident date: September 8, 2020 - Santiago de Cuba**

Detained to prevent them from demonstrating peacefully in the Sunflower Revolution. Fined between 30 and 300 CUP, mistreated, beaten, and pepper sprayed.

**63. Victims: Vladimir Martin Castellanos, Iliana Marrero Marrero, Fernando Isael Peña, Lariuska Molina Enamorado - Incident date: September 8, 2020 - Las Tunas**

Arrested to prevent them from demonstrating peacefully in the Sunflower Revolution.

**64. Victim: Esquizader Benitez - Incident date: September 8, 2020 - Santiago de Cuba**

The UNPACU activist's home was raided, he was violently detained by police officers, according to neighbors, to prevent his participation in the Sunflower Revolution.

**65. Victims: Yeroslandi Calderin Alvarado, Dannery Moya García, Mercedes Moya, Yosvani García Cursiano, Dolores Almenares De La Cruz - Incident date: September 8, 2020 - Santiago de Cuba**

The UNPACU activists were detained to prevent them from demonstrating peacefully in the Revolution of the sunflowers.

**66. Victims: Bartolo Cantillo Romero, Celina Osorio Claro - Incident date: September 8, 2020 - Guantánamo**

Detained to prevent them from demonstrating peacefully in the Sunflower Revolution. Threatened for their political activism.

**67. Victim: Otoniel Cruz Suárez - Incident date: September 8, 2020 - Ciego de Ávila**

Arrested to prevent him from demonstrating peacefully in the Sunflower Revolution, threatened with going to prison for his political activism.

**68. Victims: Berta Soler Fernández, Angel Moya Acosta - Incident date: September 8, 2020 - Havana**

Detained by a police patrol when they were preparing to deliver an amnesty request for political prisoners to the People's Power Assembly in their province. Released after 10 hours of detention.

**69. Victim: Yasmani Cárdenas Cabrera - Incident date: September 8, 2020 - Havana**

UNPACU activist, promoter of Cuba Decide, detained in the vicinity of his home, to prevent him from peacefully demonstrating in the Sunflower Revolution. Taken to the Capri police unit in the Arroyo Naranjo municipality, released after 24 hours, fined 1,500 CUP.

**70. Victims: Roberto Pérez Rodríguez, Alberto Valdés Alfaro, Héctor Jesús Álvarez Torres, Jacqueline Heredia Morales, Carlos Alberto Álvarez Rojas, Cándido Chacon Puñales, Eduardo Sánchez Puñales, Aneski Jiménez Hardit, Zuleidis Brito Techea, Yeilis Torres Cruz, Juan David Pascual Caballero - Date Incident: September 8, 2020 - Havana**

The UNPACU activists and promoters of Cuba Decide, were detained by police to prevent them from demonstrating peacefully in the Sunflower Revolution.

**71. Victim: Yuleimi de la Caridad Valdez - Incident date: September 10, 2020 - Havana**

Arbitrarily detained by the political police due to her opposition activities.

**72. Victim: Pedro González - Incident date: September 10, 2020 - Havana**

Subpoenaed by the political police for questioning and threatened due to his opposition activities.

**73. Victims: Leonardo Riveri Gascon, Ernesto Riveri Gascón - Incident date: September 10, 2020 - Santiago de Cuba**

Arrested when leaving the Los Maceos area in the Veguita de Galo neighborhood, taken in a police patrol car to unit # 2, where they were threatened with prison for their political activism, fined between 150 and 2000 CUP. They were later released.

**74. Victim: Rolando Díaz Silva - Incident date: September 12, 2020 - Havana**

Harassed and fined by the political police due to opposition activities.

**75. Victim: Arianna Ávila Gilart - Incident date: September 15, 2020 - Santiago de Cuba**

Detained at the La Maya checkpoint, she was taken off a bus on her way to her home. Police confiscated her mobile phone and suggested that she go to another province with her family, where they would give her a job.

**76. Victims: Jacqueline Heredia Morales, Carlos Alberto Álvarez Rojas, Cándido Chacon Puñales - Incident date: September 15, 2020 - Havana**

Detained when leaving the Centro Habana Pediatric Hospital, with Jacqueline's son. Taken to the Zanja police unit, fined 2,000 CUP for being on public roads after the curfew.

**77. Victim: Xiomely Padilla Bello - Incident date: September 16, 2020 - Cienfuegos**

He is in the Provincial Prison of Cienfuegos, accused of false crimes of public disorder, where he is currently awaiting trial.

**78. Victim: Roberto Serrano Delis - Incident date: September 17, 2020 - Santiago de Cuba**

Summoned to the police unit of his town and fined.

**79. Victim: Ebert Hidalgo Cruz - Incident date: September 17, 2020 - Santiago de Cuba**

He was at his home when State Security officers came to arrest him. He was handcuffed and taken to unit# 2, then transferred to the outskirts of the city, where he was beaten and threatened with death, in addition to being taken to prison with one of his sons.

**80. Victim: Yeilis Torres Cruz - Incident date: September 17, 2020 - Havana Home**

Suffered a home invasion by the political police. She was subsequently detained for seven hours.

**81. Victim: Jorge Cervantes García - Incident date: September 17, 2020 - Santiago de Cuba**

Detained by the political police for several hours due to his opposition activities.

**82. Victim: Idelisa Daniurka Salcedo Verdecia - Incident date: September 18, 2020 - Artemis**

Detained by the political police for several hours, when she was about to deliver medicine to the families of her neighborhood.

**83. Victim: Yordanis Labrada Tellez - Incident date: September 18, 2020 - Santiago de Cuba**

Police took him into custody, raided his home with his young children and his wife inside. They took several Cuba Decide stickers, two cell phones, and tore a photo of UNPACU leader José Daniel Ferrer.

**84. Victims: Yumila Yesica Miranda, Samuel Leblan Pavon, Ernesto Riveri Gascón - Incident date: September 19, 2020 - Santiago de Cuba**

Detained in the Versailles neighborhood while carrying out their political activism, taken to police unit # 2, threatened for activism in the community, fined 150 CUP.

**85. Victim: Emeregildo Duvergel Delis - Incident date: September 19, 2020 - Havana**

Political prisoner in the Sandino prison in the province of Pinar del Río. He has been beaten and is on hunger strike; he was transferred, but his whereabouts are unknown.

**86. Victim: Xiomely Padilla Bello - Incident date: September 21, 2020 - Cienfuegos**

He was on a hunger strike in the Cienfuegos provincial prison, accused of the false crime of public disorder, awaiting trial.

**87. Victim: Yordanis Labrada Tellez - Incident date: September 21, 2020 - Santiago de Cuba**

Cited to the police sector of his community, fined 1000 CUP for having a photo of the leader of the UNPACU José Daniel Ferrer and stickers of Cuba Decide on the door of his home.

**88. Victim: Claudia Genlui Hidalgo - Incident date: September 21, 2020 - Havana**

Harassed and intimidated by agents of the political police, who sent her inappropriate photos.

**89. Victim: Mary Paulin - Incident date: September 21, 2020 - Pinar del Río**

Threatened and harassed by the political police due to her opposition activities.

**90. Victim: Maykel Castillo Perez - Incident date: September 21, 2020 - Havana**

Detained by the political police for several hours due to his opposition activities. He was severely beaten.

**91. Victim: Liusban Jhon Utra - Incident date: September 25, 2020 - Santiago de Cuba**

Arrested by the repressor Adriel, taken to police unit #2, accused of hanging out with another activist distributing Cuba Decide forms, fined 150 CUP, threatened with going to prison.

**92. Victim: Yeilis Torres Cruz - Incident date: September 28, 2020 - Havana**

Detained on the public highway, in the San Miguel del Padrón municipality, taken to the La Lisa police unit, fined 150 CUP, threatened for her political activism with being taken to prison. She has disappeared and has been expatriated.

**93. Victim: Pablo Moya Delá - Incident date: September 30, 2020 - Havana**

11 days in detention, on hunger strike, transferred from Havana to the province of Santiago de Cuba. He is in the 3rd police unit, he is a cardiac patient.



**94. Victim: Maikel Herrera Bones - Incident date: September 30, 2020 - Havana**

He has been on hunger strike. The mother of his eldest son who is in charge of his visits is isolated on suspicion of having COVID-19. His 15-year-old son is alone in his home.
